We're seeking an Interprofessional Learning Specialist to bring creativity and clinical expertise to the design of innovative learning initiatives in a 12-month, part-time role (0.6 FTE, with eligibility for full benefits), with the potential for renewal depending on funding, organizational priorities, and individual contributions. As a regulated health professional with experience in clinical education, you will apply educational design skills to lead the development of learning opportunities for healthcare providers. In this senior role, you will generate new approaches, collaborate with interprofessional teams, and ensure deliverables are completed on time. Your work will integrate adult learning methods and advance simulation-, arts-, and serious game-based learning approaches, alongside digital learning technologies, to support Pallium's mission of improving the quality and accessibility of palliative care education across Canada.

- Lead and collaborate across all ADDIE phases—analysis, design, development, implementation, and evaluation—with a clinical lens.
- Contribute to credentialing processes, micro credential design, and white-label education offerings.
- Use basic project management practices to scope, prioritize, and track assigned design projects.
- Support simulation-based learning innovations and the integration of feedback, debrief, and reflection tools.
- Champion Pallium's values of compassion, collaboration, and continuous learning.

### **What You Bring**

- Regulated health professional in Canada (e.g., RN, OT, PT, RSW, etc.).
- Minimum 5 years of experience in healthcare education, including work as a clinical educator.
- Demonstrated expertise in instructional design and adult learning principles.
- Strong preference for certification in instructional design (e.g., PID, CID) and/or healthcare simulation (e.g., CHSE, SIM-One/INSPIRE).
- Proficiency with eLearning development tools and LMS platforms (e.g., Articulate, Moodle).
- Experience designing learning for interprofessional healthcare teams is preferred.
- Strengths-based, collaborative professional with strong relational and judgment skills.
- Demonstrated ability to learn new technologies quickly and apply them effectively.
